1. Welcome to participants, verification of the quorum and adoption of agenda Chair Živa Fiser welcomed participants to the MC meeting. Agenda was adopted. Quorum (26 members) was not reached with 24 members present (Albania, Austria, Belgium, Bosnia and Herzegovina, Bulgaria, Cyprus, Estonia, Finland, Germany, Greece, Hungary, Italy, Latvia, Lithuania, Luxembourg, Malta, Montenegro, Norway, Poland, Portugal, Republic of North Macedonia, Slovakia, Slovenia, Spain, Turkey).

#### 2. Information to the MC

There were 2 E-votes passed since the last MC Meeting:

- Increase the daily allowance for the Final Conference in Izola and cap the long distance travel amount
- Increase the daily allowance for the WG5 meeting in Brussels
- b) Budget status: summary from the Grant Holder Grant Holder Manager summarized the final budget from Grant Period (GP) 4 and outlined the main expenditures. For Grant Period 5, she summarized the budget, the main expenses and funds still available for activities.

Action website. Scientific output from the Action has grown over Grant Periods 1-4. Several popular articles have been translated or published in other languages such as Italian, German, and Slovene. There have been short articles, news, reports, events, and videos. The CITES species survey was launched to the Italian Botanical community. Social media overview has been presented, including analytics.

# c) Grant Awarding by the Action

Aida Dervisihi, Grant Awarding Coordinator, presented a summary of grants. 95 6645 EUR in total grants were awarded during all GPs to date. The demographics of applicants is as follows: applicants-58, Female-43, Male-15. The Grants were distributed in the following categories: VM 17, STSM 32, ITC-DCG 9. In GP4, 11 STSM were from ITC. WPB planned 1 STSM and 1 VM for GP5. The grant call will open after the Final conference, so we will know the budget better.

d) Progress on MoU Objectives, deliverables, and Goals Action Chair provided progress on the 21 Deliverables. 16 Deliverables have been completed and 5 are in progress/almost finished.

# 4. Planning

a) Revision of Work and Budget Plan of the current GP (if applicable) The Action ends on 14.4.2024, therefore, there is not a lot of discussion needed. Action Chair discussed the remaining activities in GP5 and the potential for an open call for Grants. There is some funding for Dissemination activities such as open access fees for scientific publication. We plan to publish the management guidelines for endangered species.
